Notable Trends in March 2021

Year-over-year, capital invested decreased by 6.12% and deal count only by 1.87%. However, when compared to the previous month, both capital invested and deal count increased by 53.3% and 8.49%. This is a strong sign as February represented a sizable decrease in both these categories. Median deal size in the U.S. increased 215.47% year-over-year and 26.1% compared to the prior month. This year-over-year increase shows that even though a similar number of deals are being completed, the median deal size has grown dramatically. The EV/EBITDA median has grown to 10.9x, which is

a 37.97% increase since February. Although this is a significant month-to-month increase, it still shows signs of stabilization compared to last year which saw EV/EBITDA median jump to as high as 21.0x. As we move into April and the start of the second quarter, these trends should start to stabilize as beginning of the year deal count slows.






TMT was the most active vertical in March at 8.7% of total deal count, which included seven of the largest twenty-five deals completed this month. The next three verticals, Software as a Service (SaaS), Manufacturing, and FinTech

accounted for 1.1%, 9.9%, and 4.4% of


deals this month, respectively.


The West Coast led all regions with 112 deals followed by the Mid-Atlantic with 94 deals. The Southeast, Great Lakes, and Mountain regions followed behind with 81, 74, and 51 deals completed in the month of February. The Mid-Atlantic was the home of February's largest deal, which occurred in Maryland for \$7.50 billion.

ZeniMax Media (Maryland)

Acacia Communications (Massachusetts)

On March 1st, Cisco Systems completed the acquisition of Acacia Communications for \$4.5 Billion. accelerate long-term growth.






Wrike (California)




Notable Trends in Q1



As Q1 ended, we saw year-over-year deal count decrease by 20.6% while capital invested increased by 104.5% compared to the fourth quarter of 2021. Two 4.2%. Compared to the fourth quarter of 2020, both deal count and capital invested decreased by 7.9% and 32.5%, respectively. This decline in capital invested suggests that the M&A market has slowed down from its rapid pace in Q4 of 2020.

Median deal size was up 177.8% year over year and deals in the first quarter were over \$10 billion which helps explain this sharp increase. Median EV/EBITDA is down slightly year-over-year and compared to Q4 of 2021.

Tiffany (New York)

On January 7th Moet Hennessy Louis Vuitton completed its acquisition of Tiffany & Co. for \$15.7 billion. Tiffany & Co. is a world-renowned jeweler that will deeply transform LVMH's Watches and Jewelery division, complementing LVMH's 75 distinguished Maisons. The merger has finally been completed nearly 15 months after being announced.





Concho Resources (Texas)

On January 15th ConocoPhillips completed the acquisition of Concho Resources for \$9.7 Billion. Concho Resources held over \$63 billion in assets and had proved reserves of 5.3 Billion barrels of energy as of Dec. 31, 2019. The combined firm will work to provide affordable energy, generate higher returns on invested capital and demonstrate ESG leadership.








Parsley Energy (Texas)
