

Notable Trends in June 2021

Year-over-year, capital invested increased by 196.5% and deal count increased by 18.2%. When compared to the previous month, capital invested, and deal count increased by 17.6% and 14.8%. Median deal size in the U.S. increased 345.5% year-over-year and when compared to the prior month, increased by 145.3%. This year-over-year increase shows that even though a similar number of deals are being completed, the median deal size has grown dramatically.

The EV/EBITDA median is 10.0x, which is a slight decrease since May and a sign of stabilization compared to last year, which saw the EV/EBITDA median jump to as high as 21.0x. As we move into July and the start of the third quarter, these trends should start to stabilize as beginning of the year deal count slows.







TMT was the most active vertical in June at 17.72% of total deal count, which included seven of the largest twenty-five deals completed this month. The next three verticals, Manufacturing, Software as a Service (SaaS), and Mobile, accounted for 11.19%, 6.72%, and 5.60% of deals this month, respectively.

The West Coast led all regions with 141 deals followed by the Mid-Atlantic with 124 deals. The Southeast, Great Lakes, and Mountain regions followed behind with 75, 63, and 49 deals completed in the month of June. The South was the home of June's largest deal, which occurred in Texas for \$11.6 billion.


Top 5 Associated Verticals

BBVA USA Bancshares (Texas)

In early June, PNC completed the acquisition of BBVA USA Bancshares, a subsidiary of Banco Bilbao Vizcaya Argentina, for \$11.6 billion. BBVA is a provider of banking services and has been recognized by the Small Business Administration (SBA) as one of the leading small business lenders. This acquisition positions PNC as the fifth-largest bank in the United States by assets.



TCF Financial Corporation (Michigan)

Huntington National Bank completed the acquisition of TCF Financial Corporation on June 9 for around \$6 billion. TCF is a bank and financial services provider operating throughout the United States and Canada. The acquisition positions Huntington National Bank, a regional bank holding company, with a network of branches and ATMs across eight Midwestern States.



On June 15, Just Eat Takeaway.com completed the acquisition of online food delivery company Grubhub for \$7.3 billion. Just Eat Takeaway.com is an online marketplace that connects restaurants with users in Europe and North America. This transaction represents the company's entry into the United States online food delivery business.







Cantel Medical (New Jersey)

In early June, Cantel Medical, a manufacturer of hospital supplies for infection prevention, was acquired by Steris, the global leader in contract sterilization services. The \$4.6 billion deal adds to Steris' infection prevention focused product and service portfolio and will allow the company to reach dental customers.






Kraft Heinz (Planters Peanuts & Snacks Business)

On June 7, Hormel Foods completed the acquisition of the Planters peanuts & snacks business of Kraft Heinz for \$3.35 Billion. Hormel is a protein-focused branded food company with number-one market position in turkey, shelf-stable meat, pepperoni, deli meat, guacamole, and canned stew. This acquisition, the largest in company history, aligns with strategic efforts to enhance snacking offerings.




Notable Trends in Q2



As Q2 ended, we saw year-over-year deal count increase by 27.7% while capital invested increased by 44.7%. Compared to the first quarter of 2021, deal count decreased by 13.3% and capital invested increased by 12.8%. This decline in deal count suggests that the M&A market has slowed down from its rapid pace in Q4 of 2020.

Median deal size was up 345.5% year over year and increased 145.3% compared to the previous month. Four deals in the second quarter were over \$10 billion which helps explain this sharp increase. Median EV/EBITDA is down 10.7% year-over-year.

Quarter 2 Transaction Highlights

Speedway (Ohio)

On May 14, 7-Eleven acquired Speedway, a subsidiary of Marathon Petroleum, for \$21 billion. Speedway is gas and convenience-store chain operator that provides food and beverages as well as car wash and fuel safety services. The acquisition strengthens 7-Eleven's financial profile while aligning with the company's growth trajectory.







Varian Medical Systems (California)

In mid-April, Siemens Healthineers completed its acquisition of Varian Medical Systems for \$16.4 billion. Varian is an American radiation oncology treatment and software maker, generating more than \$2 billion in annual revenue. They will now operate jointly with Siemens, a German medical technology company, on a project called EnVision. The goal of this partnership is to establish a digital, diagnostic, and therapeutic ecosystem combining the two companies' complimentary styles while taking a leap in the cancer and healthcare fields.



BBVA USA Bancshares (Texas)

In early June, PNC completed the acquisition of BBVA USA Bancshares, a subsidiary of Banco Bilbao Vizcaya Argentina, for \$11.6 billion. BBVA is a provider of banking services that has been recognized by the Small Business Administration (SBA) as one of the leading small business lenders. This acquisition positions PNC as the fifthlargest bank in the United States by assets.



FLIR Systems (Oregon)

On May 14th Teledyne Technologies completed its acquisition FLIR Systems for \$8.29 billion. FLIR Systems is the world leader in the design, manufacture, and marketing of thermal imaging infrared cameras. FLR Systems will change its name to Teledyne FLIR and will operate under Teledyne's digital imaging segment.



Inphi (California)

Marvell International acquired Inphi for \$10 billion on April 20th. Inphi is known for making semiconductor chips used by storage facilities and manufacturers. Marvell, an industry leader, has used this acquisition to strengthen their position in the semiconductor space. Marvell will use Inphi's technology to assist hyperscale cloud data centers and use their electro-optic infrastructure, which is eight times faster, for 5G support. This acquisition will allow Marvell to compete with NVIDIA and Google while positioning themselves to take advantage of 6G wireless in the future.
